Please note that Question paper will not be downloaded without your presence & ultimately the distribution of question papers to the students would be late. Therefore you should be remain present at the Examination Centre within scheduled time of downloading of question papers and be present at the time of Packing of Answer Books.

The duties of the Joint Chief Superintendent has already been sent to the Joint Chief Superintendent of the Examination Centre.

The provision under Section 48(4) of the Maharashtra Public Universities Act, 2016 is reproduced as under: "It shall be obligatory on every teacher and on the non-teaching employee of the University, affiliated colleges, community colleges or recognized institutions to render necessary assistance and service in respect of examinations of the university and evaluation of students as prescribed by statutes. If any teacher or non-teaching employee fails to comply with the order of the university or college or institution, in this respect, it shall be treated as misconduct and the employee shall be liable for disciplinary action. In case of failure on the part of the teacher or non-teaching employee of any affiliated college, conducted college, community college or recognized institution, to comply with the order of the university in this regard, the Vice-Chancellor shall have power to take an appropriate action against them, which may include imposing penalties including suspension of approval to the appointment of any other person as prescribed by the Statutes."

Need to submit TADA Form No.4 and specimen proforma regarding the purchase of answer books to the Joint Chief Superintendent and the principal/Chief Superintendent as well.

In order to get the signature of the Principal / Chief Superintendent of the Examination Centre, you may get a certificate from the Principal / Chief Superintendent of the Examination Centre in order to enable this office to recommend you for an early date. It may please be noted that your remuneration and T.A./D.A. bill will not be recommended for sanction unless (1) Absence statement (2) Statement of Answer Books used at the Examination Centre and (3) Statement showing the date wise and session wise number of candidates appeared for the Examinations and (4) Your detailed report regarding conduct of the Examination and the Joint Chief Superintendent of the Examination Centre. Your bills should reach this office along with prescribed papers within a week after the end of the examination centre.

Please sign your acceptance of this assignment in the enclosed Form No.4 immediately. (Copy is also available on University Website) If you are not willing to accept the assignment, communicate this office with reason, through email/Phone/Fax.
